Dear Senator Ossoff,

Thank you for your service and support to the Military Veterans' community and our families. Keep up the great work!

I recently watched your latest news interview, and I sincerely applaud your efforts in combating the Pentagon's wasted spending in the defense contracting industry, regarding base facilities and housing mismanagement.

As more "victims" of Toxic Exposure (TE) come forward in exposing the Pentagon's negligence to provide a "toxic free" workplace and living place. Veterans and their families deserve to be well compensated.

As these service members begin their transition from active duty service to civilian life, toxic exposure *(TE)* in cases like this, should be examined no different than awarding *service connected disabilities* for *(TE)* in the fields, during training exercises or mission execution, as well as while working or living abroad— with their families.

Therefore, I ask the Senate for bi-partisan support for special consideration for <u>family members</u> that have already tested positive for (TE); granting immediate access to <u>quality healthcare</u>, <u>Medicare and Social Security disability compensation</u> during this ongoing investigation.

Your work for Georgia's residents in improving access to quality healthcare facilities is immeasurable, especially for our young children, as they continue to battle allergies, chronic respiratory disease, and other related illnesses caused by exposure to mold and mildew pathogens, throughout our climate change.

Thanks again for exposing ongoing military corruption, and the severity of damage caused by the Pentagon's negligence to improve the quality of life for our Military families. Truthfully speaking, you are the first Senator since Senator Grassley, in his early days, to challenge military corruption of this magnitude.

While watching your interview, I recalled the cesspool of defense contracting fraud I witnessed while stationed in San Diego, in early 2006-2009.

YES, this is a systemic problem nationwide and is rapidly expanding globally, which is why the Pentagon continues to ignore whistleblowers' complaints, as well as concrete evidence of fraud. It's become to profitable.

When I discovered and later reported evidence of contract mismanagement to the DoJ, the fraud was <u>directly linked</u> to illegal building projects in multiple states, involving members of the Reserve Community, mostly business executives. Several of the "rigged" defense contracts supported "Veteran Owned" businesses and their Prime Vendor affiliates.

These contract portals afforded vast opportunities to engage in illegal consultant services, revolving door practices, illegal building projects of warehousing and other facilities, etc., with little to no federal oversight, especially from members within the Judge Advocate General Community, which was apparent in my whistleblower case.

This brings me to the matter at hand. I recently discovered, on his public LinkedIn profile, the Navy's prosecutor in my "adultery case" Ret. Navy Commander, Kevin Messer, is now serving as U.S. Administrative Law Judge at Social Security Administration, San Diego.

Sir, I'm speechless.

As a survived victim of dozens of Civil and subsequent Human Rights Violations, as a direct result of (then) LCDR Kevin Messer's blatant abuse of authority while carrying out the prosecution of my case, and the Navy's own admission of such crimes, I request that you expand the scope of your investigation, at the very least, disqualify him from this position and to never be allowed to practice law again.

Given evidence of his past abusive and belligerent characteristics which are clearly detailed throughout my Equal Opportunity and IG complaints, and trial records— I feel that he has grave potential to abuse his authority in his current position as an Administrative Law Judge within the Social Security Administration, worse than the miscarriage of justice in my case.

As legal evidence gives us proof that he's destroyed evidence and covered up fraud once before, while serving on active duty... It is extremely likely that he will do it again.

No different than other large military bases, San Diego officer's community is tight niche and take care of their own when it comes to maintaining their lucrative and expensive retirement lifestyle— By any means necessary, including ensuring full medical compensation benefits are awarded without a hitch; much like their retirement benefits.
